




Figure 1. Forward Current vs. Forward Voltage




Figure 3. Typ. Cross Modulation Distortion vs. Frequency  $f_2$ 





Figure 2. Differential Forward Resistance vs.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
